Bobby Mawyer, Chief of Police advised that he received a letter from the Parent-Child Development Corporation requesting that a portion of F Street have no parking signs. The customers will park on the Street, run into PCDC to pick up their child and run back out to their vehicle. The parking issues occur during pickup and drop off times.

Bobby Mawyer advised that there has been an arrest in the Break and Entering issues in Town. We have recovered some of the stolen items and the investigation is on-going.


