# PUBLIC WORKS COMMITTEE MINUTES November 10th 2021

Mr. Lawrence called the meeting to order at 9:16 A.M. at 802 Main Street, West Point, Virginia 23181. Members present included Robert Lawrence, Chairman; James Pruett and Chris Vincent.

#### II. Adoption of Minutes

A. October 14th 2021

Mr. Lawson made a motion to adopt the minutes as presented, seconded by Mr. Pruett. Upon a unanimous vote, the motion was approved.

#### III. Waterline Replacement Project

Walt Feurer presented the waterline project that would replace the waterline on Rt 30 in front of WestRock. There have been numerous failures over the past years. The project would replace old, galvanized pipes with PVC pipes, it would remove three fire hydrants West of Rt 30 and replace them with five hydrants on the East side of Rt 30. The town has discussed the project with WestRock, and they have no concerns with the project. The next step is to authorize Wilson Engineering to move forward with putting the project out to bid, Wilson Engineering would over see the project. APA funds will be used to pay for the project.

#### IV. Municipal Utility Assistance Grant

Mr. Edwards presented a letter from the Stated Department of Housing and Community Development awarding \$84,465.84 to the town to assist with water bills that are over sixty days past due prior to August 31, 2021. The funds do not pay penalties or late fees, it only provides relief for the actual water bill. The funds will be split between the outstanding bills that qualify. Mr. Edwards also stated that the funds are to be paid through King William County, the Interim County Administrator has said he will work with the Town on the payment process.

#### V. General Information

1. Water Leakage Loss

Mr. Edwards advised that during the search for the water loss the town has been experiencing, the leakage has been discovered to be a commercial meter that has been replaced.
