I. Work Session at Town Hall, 329 6th Street, West Point, Virginia 23181.

A. Real Estate Tax Refund to Town Resident

Mr. Hudson advised that the Vranian family have discovered that they have been paying double taxes on their Real Estate property for several years. The King William Board of Supervisors is reviewing the issue. The family had four lots that were merged into one lot. The family has been paying taxes for the four lots and taxes for the one merged lot, the family is claiming a double tax. The County will be refunding some taxes and the Town will have to research the issue to know how much taxes were paid to West Point.

B. Downtown Parking

Mr. Edwards presented Town Council with a draft letter to downtown business owners and asked Town Council if they had any changes to the letter.

A discussion ensued regarding downtown parking and the request by "4 Paws" for an unloading zone on 7th Street.

The consensus of Town Council is for the Town Manager to send the letter to downtown businesses regarding parking and send a letter to 4 Paws regarding their request for an unloading zone at the Thrift Store.

C. Fire Department Property on 7th Street

Mr. Edwards advised that the Fire Department has approached the Town regarding the purchase of two lots they own on 7th Street. Mr. Edwards asked Town Council if they are interested in purchasing the lots.

Jack Lawson stated that the lots are worth between \$25,000 and \$30,000.

The consensus of Town Council is that the Town Manager offers the Fire Department \$25,000 for the lots.
